**SUB : Regulation and Fees w.r.t Summer Semester registration for CIA Improvement,
Attending Classes and Examination**

With the approval of Vice Chancellor – DSU and pending approval of the university statutory bodies , the following are hereby notified pertaining to the Summer Semester registration for CIA Improvement, Classes and Examinations:

1. Improvement of CIA :

- (i) The students having scored F grade in a particular course, with CIA less than 40 % of the upper limit of specified CIA for the particular course, are eligible to improve the CIA, course wise, before appearing for summer term examination, after paying the fees notified by the university.
- (ii) The students opting for CIA improvement, need not register for attending the Summer Term Classes.
- (iii) The students opting for CIA, can directly register for summer term examinations, by paying the fees as notified by university.
- (iv) The CIA Scored by the students opted for improvement in a particular course will be considered as Final CIA in that course and previously scored CIA in that course will get nullified.

2. Fees :

- (i) Registration for CIA improvement : Rs 2000/- per Course
- (ii) Registration for Summer Term Classes : Rs 1,500/- per Credit of the course
- (iii) Registration for Summer Term Examination : Rs 1000/- per Course

The particulars notified in this notification will be effective from the date of this notification.
