Forensic Insight and Analytical Rigor: Crime Scene Investigation Competition at Dayananda Sagar University

Participants engaged in intensive suspect interrogation, detailed scene analysis, and the synthesis of clues to construct cogent investigative narratives. The adjudication process was overseen by a distinguished panel including Assistant Professors Ms. Sakshi Mehta, Ms. Arifa Choudhury, and Mr. Sanjay Utaygi, who evaluated the presentations on the basis of logical integration, investigative methodology, and clarity of reporting.

The collaboration of Richard, K. Karthik, and Benantion was particularly lauded for their analytical prowess and strategic reasoning, earning them the competition's top honors. Additionally, Mohd Rayaan received the Best Suspect Award for his compelling portrayal that significantly elevated the investigative challenge posed to participants.

Under the coordination of Ms. Arifa Choudhury, Mr. Nithin Rajeev, and Ms. Shivani Dutta, the event transcended traditional academic exercises, fostering critical analytical skills, collaborative problem-solving, and advanced communication. Empowering Legal Perspectives: Workshop by the Legal Aid Clinic, School of Law, Dayananda Sagar University

On January 17, 2025, the Legal Aid Clinic of the School of Law at Dayananda Sagar University (DSU) hosted a pivotal workshop aimed at orienting law students towards the Pan-India Zonal Reel Making & Short Film Competition. This event, organized by NALSA under three distinctive themes, was expertly coordinated by Ms. Shivani Dutta and Mr. Sanjay Uthaygi. The practical component involved creating reels and videos to enhance awareness among workers and employees. The workshop, which attracted 38 enthusiastic law students, delved into three significant legal themes:

A. NALSA (Legal Services to Senior Citizens) Scheme, 2016: Led by Ms. Stency Maria Mark, this session addressed the unique challenges and opportunities presented by India's growing senior citizen population. The discussion encompassed constitutional provisions and legal frameworks tailored to protect senior citizens, such as the Hindu Adoption and Maintenance Act, 1956, Muslim Personal Laws, and the newly introduced Bharatiya Nagarik Suraksha Sanhita, 2023. A focal point of the session was the Maintenance and Welfare of Parents and Senior Citizens Act, 2007, particularly its key protective provisions. Additionally, the role of legal service clinics and various governmental initiatives aimed at safeguarding senior citizens' rights and interests was thoroughly explored.

B. NALSA (Legal Services to Victims of Acid Attacks) Scheme, 2016: Prof. Shantanu Pachahara facilitated a compelling session on the legal and social dimensions of acid attacks under the NALSA scheme. He highlighted the disturbing increase in acid attacks, often motivated by gender-based violence and dowry disputes, and discussed their severe impacts, such as physical disfigurement and significant financial strain on victims. The session also covered the enhancements in legal responses, including the Criminal Law (Amendment) Act, 2013, which introduced stricter penalties and mandated compensation. Prof. Pachahara emphasized the scheme's commitment to providing free legal aid, medical support, and raising awareness while enhancing stakeholder capacity to support acid attack victims effectively.

C. NALSA (Legal Services to the Workers in the Unorganised Sector) Scheme, 2015: Prof. (Dr.) Heena Ghanshyam Patoli led an informative session focused on the National Legal Services Authority's scheme for unorganized sector workers. She provided an extensive overview of the scheme's goals to institutionalize crucial legal services for all unorganized workers. The session aimed to spread knowledge among workers about their rights under existing legislation, and to offer counseling and assistance, thereby empowering them to advocate for their entitlements effectively.

It highlighted the key differences among the various legislations and their impact on individuals, businesses, and the Indian digital economy. It further explored the key differences in regulatory approaches, compliance requirements, user rights, and business obligations. Additionally, the presentation highlighted the broader implications of these changes on individual privacy, corporate data governance, and India's digital economy**, assessing how these regulations align with global standards and impact cross-border data flows.

Research Grant: Dr. Moharaj, has also been awarded a prestigious research grant from the Indian Council of Social Science Research (ICSSR), Ministry of Education, Government of India! Dr. Moharaj will serve as a Co-Project Director on the ground-breaking research project titled: "Evaluation of Jal Jeevan Mission (JJM) in Enhancing Community Health and Economic Prosperity: Evidence from Selected Indian States." The project

brings together a dynamic team of esteemed researchers like Dr. Suresh Kumar Patra (Central University of Rajasthan), Dr. Dibakar Sahoo (Banaras Hindu University), and Prof. Aparajita Biswal (Rama Devi Women's University).

International Seminar Presentation: Professor Arifa Sultana Choudhary, along with Professor Nithin Rajeev, Assistant Professor of Law at DSU, co-presented a seminal paper at the two-day international seminar organized by ICERP, CUSAT in collaboration with the National Human Rights Commission from January 22nd – 23rd, 2025. Their research, under the theme "Protection of Copyright in Cyberspace: Global Management Models for Regulating IP on the Internet," delved into the complex dynamics of copyright law within the realm of social media—a landscape where platforms like Instagram, YouTube, and TikTok both empower creators and challenge traditional notions of fair use and intellectual property enforcement. Their work critically examines the imperative to balance IP rights with the need for innovation in a digitally driven era.

Virtual Faculty Development Programme: From January 10th to 14th, 2025, Prof. Choudhary participated in a 5-Day Virtual Faculty Development Programme organized by KETAS Ed. Foundation & World Cyber Security Forum in collaboration with Gujarat National Law University, Gandhinagar. This intensive programme addressed the nuances of cyber law, digital forensics, data privacy, and emerging cybersecurity challenges, offering participants a deep dive into the latest developments and strategies in cyber legal studies. The knowledge gained is poised to significantly bolster her teaching and research capabilities, particularly in navigating evolving cyber threats and legal frameworks.

Accepted Abstract for International Conference: The abstract titled "Bridging the Gap in Justice: Advocating Gender Neutrality in Sexual Offense Laws" by Prof. Choudhary has been accepted for presentation at the International Conference on Emerging Issues in Criminal Law, scheduled for March 21st–23rd, 2025. This critical piece of research evaluates the pressing need for gender-neutral sexual crime laws, scrutinizing global legal frameworks, societal challenges, and the broader human rights implications. Her work is dedicated to addressing legal disparities and advocating for reforms that ensure comprehensive justice for all victims of sexual offenses, thereby contributing to the global discourse on gender justice and legal inclusivity.

Legal Updates

- 1. If A Intends To Kill B But Mistakenly Kills C, Intention To Kill C Is Attributed To A: Supreme Court Explains 'Transmigration Of Motive'- The Supreme Court recently observed that Section 301 of the IPC (Culpable homicide by causing the death of a person other than the person whose death was intended) reflects the doctrine of transfer of malice or the transmigration of motive. Explaining this provision, the Court said that culpable homicide may be committed even if the offender causes the death of a person he did not intend. Provided that the killing takes place while doing an act which the offender intended.
- 2. Bombay High Court lifts part of Pidilite's trademark injunction on Astra Chemtech- The Bombay High Court has lifted part of an injunction in a trademark dispute between Pidilite Industries Limited and Astra Chemtech Private Limited, ruling that Pidilite misled the court while obtaining the order. Justice Manish Pitale, in an order on February 6, 2025, found that Pidilite knowingly made misleading statements about Astra Chemtech's registered trademark to secure an ex-parte injunction on October 24, 2024. The court vacated the injunction related to Astra Chemtech's six-rhino trademark but upheld restrictions on the use of the "SH" trademark.
- 3. Supreme Court relief for Discovery India staff amid threat from Asaram's followers- The Supreme Court on 6th February, 2025 issued a notice on a plea filed by TV broadcaster Discovery Communications India and some of its employees, asking Delhi Police to provide protection to them. The petitioners had approached the Supreme Court, alleging threats and intimidation from

supporters, fans, and devotees of disgraced godman Asaram Bapu, who was convicted in a rape case and is currently out on bail, and sought protection. A bench led by Chief Justice of India Sanjiv Khanna also requested the police authorities in the concerned states to protect the right of the petitioners to use their offices and ensure that no criminal intimidation or physical harm is meted out to them.

- 4. Karti Chidambaram moves Delhi High Court to quash fresh CBI case over Diageo Scotland bribery- The CBI has accused Chidambaram, Congress leader and Sivaganga Member of Parliament (MP), of taking bribe from Diageo Scotland in exchange for lifting a liquor import ban in 2005, when his father, P Chidambaram was the Union Finance Minister. The plea by Chidambaram came up for hearing on Thursday before Justice Vikas Mahajan. However, Chidambaram's lawyer sought adjournment citing unavailability of the arguing counsel in the matter. The same was allowed and the matter was posted for hearing on April 16. Chidambaram has been booked by CBI for offences under Section 120B (criminal conspiracy) and 420 (cheating) of the Indian Penal Code and for offences under the Prevention of Corruption Act. Chidambaram is also an accused in Aircel-Maxis case, INX Media case and Chinese Visa case.
- 5. 'Debt Has Been Recovered Multiple Times Over': Vijay Mallya Approaches Karnataka HC Seeking Information On Total Amount Recovered By Banks- The Karnataka High Court on Wednesday (February 5) issued notice to banks on a petition filed by fugitive liquor baron Vijay Mallya, seeking a direction to the former to provide a statement of accounts for the amounts owed by him, United Breweries Holdings Limited (in liquidation) and other certificate debtors.
- 6. Too Vague': Karnataka High Court Rejects PIL For Inquiry Against Legislators Over Alleged Disproportionate Assets: Karnataka High Court on Thursday (February 6) dismissed a public interest litigation filed seeking a direction to Lokayukta to hold enquiry against the MLA, MPs and MLCs whose assets are disproportionate to their known sources of income, by considering the representation made by the petitioner in December 2023.
- 7. Sharon Raj murder: Kerala High Court issues notice to State on Greeshma's appeal against death penalty- The Kerala High Court on Thursday issued notice to the State of Kerala on the appeal filed by Greeshma, the convict sentenced to death for the murder of 23-year-old Thiruvananthapuram resident Sharon Raj. Her appeal challenging the conviction and death sentence was heard by a Bench of Justices PB Suresh Kumar and Jobin Sebastian. The Bench sought the response of the State to the plea challenging her conviction and death sentence and directed the State to respond to the application filed by her to suspend her death penalty. Pertinently, the Court suspended the three-year jail sentence of Greeshma's uncle Nirmala Kumaran Nair who is a co-accused in the case.

- 8. TN Governor devised own procedure; withheld bills despite Punjab verdict: Supreme Court- The Court while dealing with petitions filed by the Tamil Nadu government against the Governor's refusal to assent to several Bills passed by the State Legislative Assembly, including those concerning the appointment of Vice Chancellors to State Universities, noted that by indefinitely withholding assent to Bills, the Tamil Nadu Governor appeared to have rendered a proviso to Article 200 of the Constitution redundant (where a Bill is sent back by the Governor for reconsideration by the State legislature). In such cases, if the returned Bill is passed again by the State legislature and re-presented to the Governor for assent, the proviso lays down that "the Governor shall not withhold assent." Tamil Nadu governor seems to have devised his own procedure. He rendered the second part of the proviso redundant by his actions," the Court observed today.
- 9. Not given a fair hearing by NCLT as counsel was unavailable: Byju's RP tells NCLAT-Pankaj Srivastava, who was earlier tasked to serve as the Interim Resolution Professional (IRP) in the ongoing insolvency proceedings against ed-tech firm Byju's, has moved an appeal against the order of the National Company Law Tribunal (NCLT) that had called for the initiation of disciplinary proceedings against him. Srivastava has contended that he was not heard properly before the NCLT order against him was passed. He added that the NCLT's order is contrary to established legal norms. According to him, the order contains unreasonable and unfair observations and was passed without affording him a fair opportunity to be heard.
- 10. Delhi court summons ED Director over failure to provide legible copies of evidence to PMLA accused- A Delhi court has summoned the Enforcement Directorate (ED) Director Rahul Navin over the central agency's failure to provide legible copies of documents (evidence) to accused in a case under Prevention of Money Laundering Act (PMLA).
