NOTIFICATION

Implementation of reservation policy at Dayananda Sagar University for 2023–24 Dayananda Sagar University, a state Private University, was established on 16/05/2014 by the notification of Government of Karnataka (No. ED 95 ERC 2014), enacted through Dayananda Sagar University Act, 2012 (Karnataka Act No. 20 of 2013), published in Karnataka Gazette No. 734, part-IV-A, dated 09/05/2013.

Whereas Section 9 of the Dayananda Sagar University Act, 2012, mandates that forty percent of the admissions in all courses of the university shall be reserved for the students of Karnataka State and admissions shall be made through a Common Entrance Examination conducted by the state Government or its agency and seats shall be allotted as per the merit and reservation policy of the State Government from time to time.

Following the Government Order No. SWD 225 BCA 2000, dated 30/03/2002, and KEA notification, the reservation policy at Dayananda Sagar University for admissions to state Government quota of professional courses shall be:
